DES Report:

- 8 Invest, 7 notifications, Hazmat 2 responses, 2 notifications
- Locution: 2 cross streets added back in, Announcing Box in front of numbers. Gerry is going to send out a survey for the AB to vote on sequence.
- Drill Notifications/Passive Chief Notifications new policy draft would be a dispatch and clear.
- Reminder to dispatchers to announce the RIT Units on dispatch
- Feedback from Fire Board on the IDA events, with more after action reports to come.
- PSTC New prices going into effect. Matt Fink will take over as Fire Training Coordinator.
- CAD 33's section of Salsbury Township Lancaster County now lives in Lancaster's CAD
- EW Car 1 went into effect Nov 1st
- Channel Programming programing requires Serial Cable and the audio files will fail. Working with Devin.
- New Routers rolling out the new routers. Will get a new Sharkfin antenna. The second antenna will not be needed. DES is still working out the agencys that have the VRM modems in their Chief's vehicles
- Montco Radios- Montco Solicitors requested everyone wait until they do a county wide radio reprogramming.
 Chester County is ready.

- North Meet at Station 69 next Wednesday. Have Limerick Drill on the 16th.
- South Meet at the end of the month
- **East** Discussed Water Rescues from IDA and what resources they have. They do have good coverage in the East. Berwyn's incident took a lot of resources.
- West Not Present
- **Central** Concern with RIT companies being called and then stripping the stations of all the resources.
- EMS Big discussion on JRH Closing and essentially 1400 ER Patients need to find other hospitals that are already full. EMS Council meets with Tower Health every week and meet with ER Nurse Managers every 2 weeks to work on mitigation efforts. 45mins to 2hrs to offload patients at hospitals.
- Fire Police Nothing to Report
- RTF Met on the 20th. Had a debrief training of the Florida Condo Collapse. Getting feedback from the Flooding during IDA. Running a Rope High Angle 1 course to kick off by year's end. Region hosting a Tower High Angle course.
