Minutes for the May 08, 2024, Meetings

PCH Foundation Meeting

Call to Order:

- The meeting was called to order by President Jeff Kimes at the Ridge Fire Co at 1901Hrs.
- The pledge to the flag was recited and a moment of silence was observed.

Guest Speakers:

- We welcomed our local state elected officials to speak with the association.
 - Rep. Paul Friel Announced a Bill passed through the House to allow workman's comp to cover Mental Health and PTSI.
 - Rep. Joe Ciresi Representing our bordering townships in Montgomery County. Its budget season, come to your representatives when you need something, let them know your wish list so they can see if they can help. Worked to get PennDOT to allow for each volunteer first responder to have a free vehicle registration and PennDOT said no, too much lost revenue. Joe stressed needing assistance from the fire companies and public on getting the Kiem Street Bridge Replacement moving again.
 - Senator Katie Muth Chair of Veterans Affairs and Public Safety. Discussed the caps of State Loans and increasing them. EMS Tax Rebate \$500. Distracted driver bill amended to allow the use of portable radios in personal vehicle. PTSI Bill on the Senate side to be reviewed and voted on. Reiterated about letting them know about funding needs and requests.
